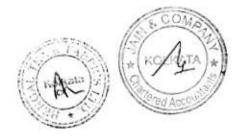

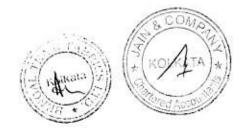

- (6) The Cumulative impact of the change in policy due to implementation of Accounting Standard (AS) -10 (Revised) and Accounting Standard (AS) 2 (Revised) as per note 4 & 5 above, Loss before tax for the year ended 31st March, 2017 is lower by ₹ 19 Lakhs.

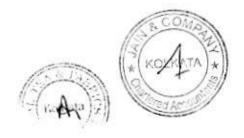
