

Pursuant to the provisions of Section 108 and Section 110 of the Companies Act, 2013 read with the Companies (Management and Administration) Rules, 2014 (Rules) and SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, consent of the Shareholders of the Company was required to pass a Special Resolution for increasing the Limits of Intercorporate loans, guarantees and investments prescribed under section 186 of the Companies Act, 2013 as given in the Notice of Postal Ballot dated 28th December, 2023.

- 1. I, Swati Bajaj, Partner, M/s. Bajaj Todi & Associates, Practising Company Secretaries, have been appointed by the Board of Directors of the Company as the Scrutinizer for the purpose of scrutinizing the Postal Ballot process through remote voting, in a fair and transparent manner, and ascertaining the results on E-voting, on the resolution contained in the Postal Ballot Notice dated 28-December-2023.
- 2. The Postal Ballot process has been carried out as per the provisions of Section 108 and 110 of the Companies Act, 2013 (Act) and Rule 22 read with Rule 20 of the Companies (Management and Administration) Rules, 2014 as amended by Companies (Management and Administration) Amendment Rules, 2015 to the extent applicable read alongwith the guidelines issued by Ministry of Corporate Affairs (MCA), vide its General Circular No. 14/2020 dated 8th April, 2020, General Circular No. 17/2020 dated 13th April, 2020, General Circular No.20/2020 dated 5th May, 2020 and General Circular No. 09/2023 dated 25th September (collectively referred to as "MCA Circulars").
- 3. The Management of the Company is responsible for ensuring the compliance with the requirements of the Act and Rules relating to voting through electronic means on the resolution contained in the Postal Ballot Notice.
- 4. My responsibility as a Scrutinizer, remote e-voting process, is restricted to make a Scrutinizer's Report of the votes cast in "favour" or "against" the resolutions based on the reports generated from the E-voting system as provided by National Securities Depository Limited (NSDL), the authorised agency engaged by the Company to provide E-voting facility.
- 5. Further to the above, I submit my report as under:-
 - The e-voting period remained open from Friday, 05-January-2024 (9:00 A.M.) to Saturday, 03-February-2024 (05.00 P.M.)
 - ii) The members of the Company as on the "cut-off" date i.e. Friday, 29-December-2023 were entitled to vote on the Special Resolution as set out in the Postal Ballot Notice dated 28-December-2023, and whose e-mail IDs were registered with the Company/ Depositories/ RTA.
 - iii) The members of the Company were required to cast their votes through 'Remote E-voting' facility provided by C.B. Management Services (P) Limited.

- iv) Thereafter, the votes cast through remote e-voting were unblocked on Saturday, 3-February-2024, after close of the e-voting facility, in the presence of 2 witnesses, who are not in the employment of the Company.
